FINAL RESULTS

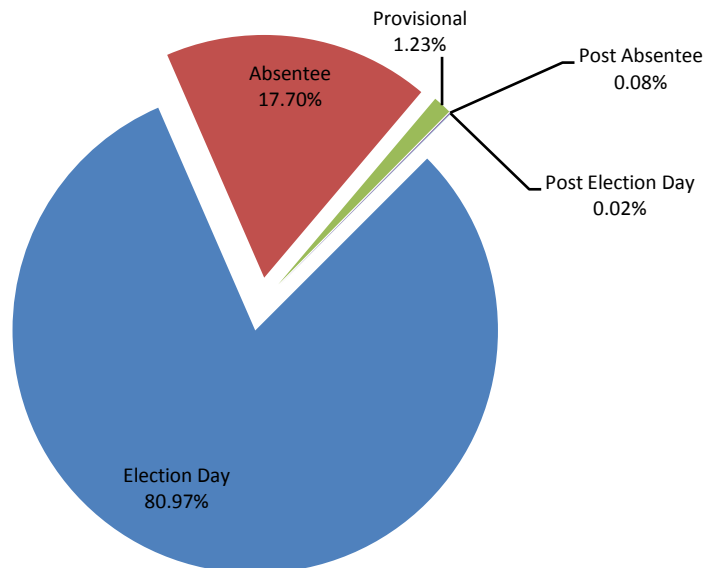
Official Election Results for the August 7, 2012 Special Election are attached in the "Election Summary" report.

SUMMARY OF OFFICIAL CANVASS

There were a total of 11,920 ballots tabulated for the August 7, 2012 Special Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

ABSENTEE / VOTE BY MAIL

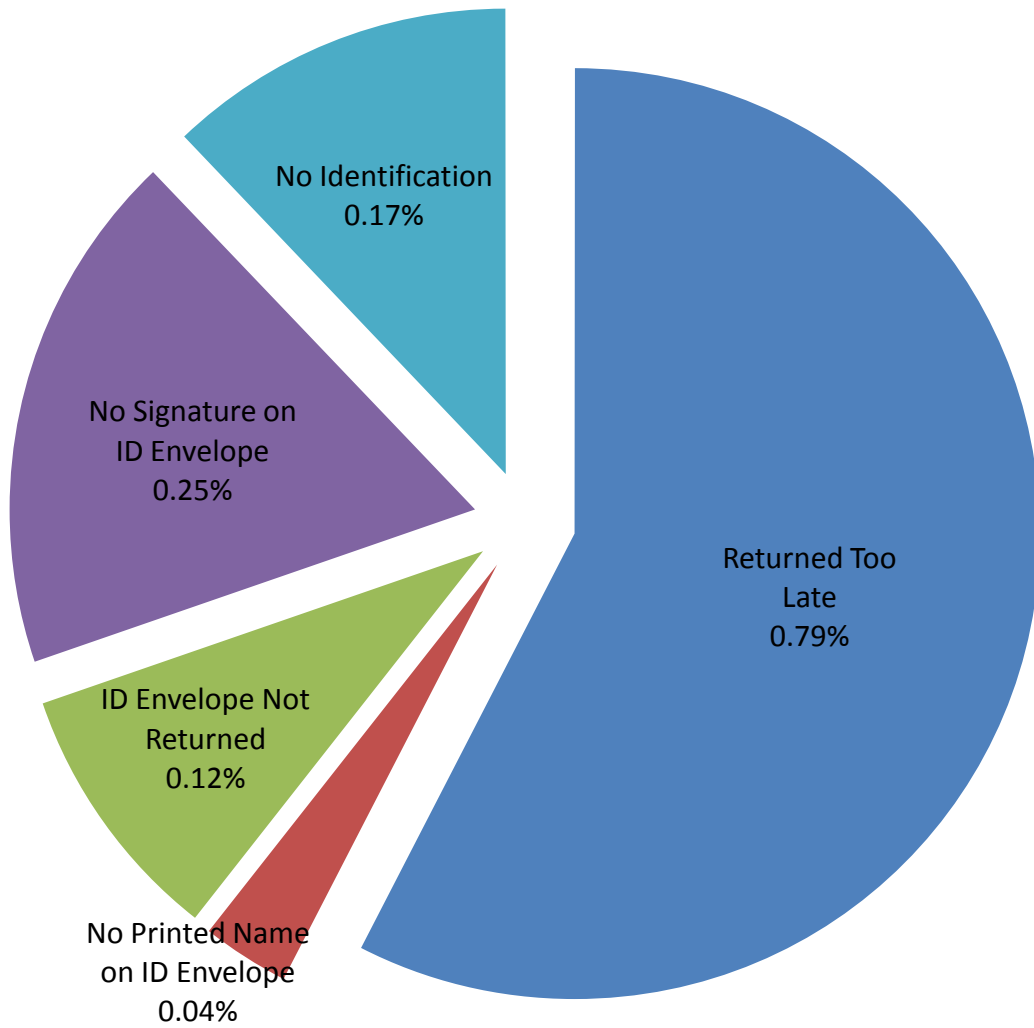
The Cuyahoga County Board of Elections received a total of 2,300 valid Absentee/Vote by Mail applications. Of those requests, 2,152 ballots were returned (93.57%). The Ballot Department tabulated 2,119 Absentee / Vote by Mail Ballots. There were 33 ballots challenged in this election resulting in a challenge rate of 1.53%*. Details of the challenges are below.

*The Absentee Ballot Challenge Rate is 0.66% when the Absentee Ballots postmarked after the deadline are excluded.

PROVISIONAL VOTING SUMMARY

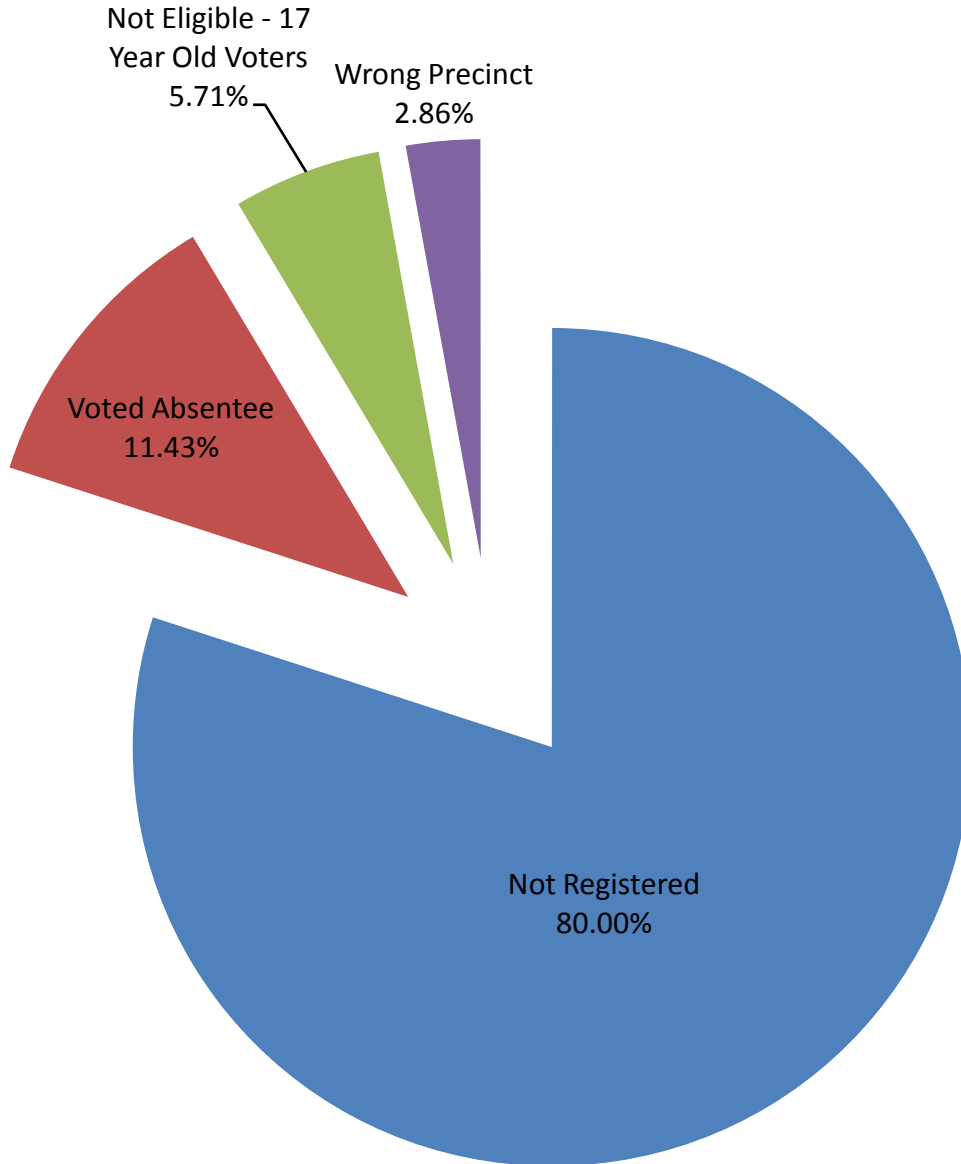
A total of 182 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 147 (80.77%) were valid and tabulated by the Ballot Department. There were 35 invalid Provisional Ballots resulting in a 19.23%* rejection rate for this election. Details of the rejections are below.

* The Provisional Ballot Rejection Rate is 1.75% when Provisional Voters who have already cast an Absentee Ballot and those who are not currently registered to vote are excluded.

POLL BOOK JUSTIFICATION AND BALLOT RECONCILIATION

There were a total of forty-six (46) precincts involved in this election. The number of signatures in the Poll Books matches the number of Ballots Cast in forty-five (45) precincts. The remaining precinct has two less signatures than votes tabulated.

A review of the ballots cast on Election Day was completed for this precinct.

The number of ballots ordered, equals the number of ballots voted, soiled and unused in all forty-six precincts.

There were no automatic or requested recounts for this election.

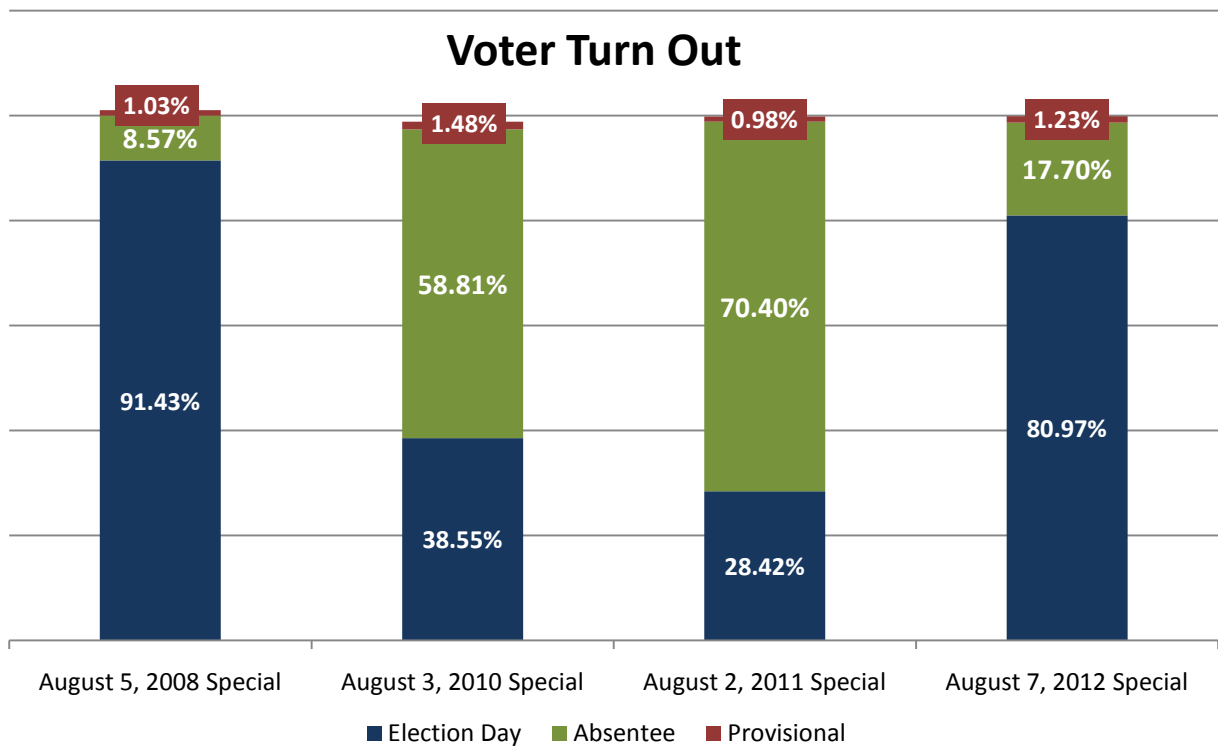
AUDIT

The post-election audit will begin on Monday, September 10th at 9:30AM.

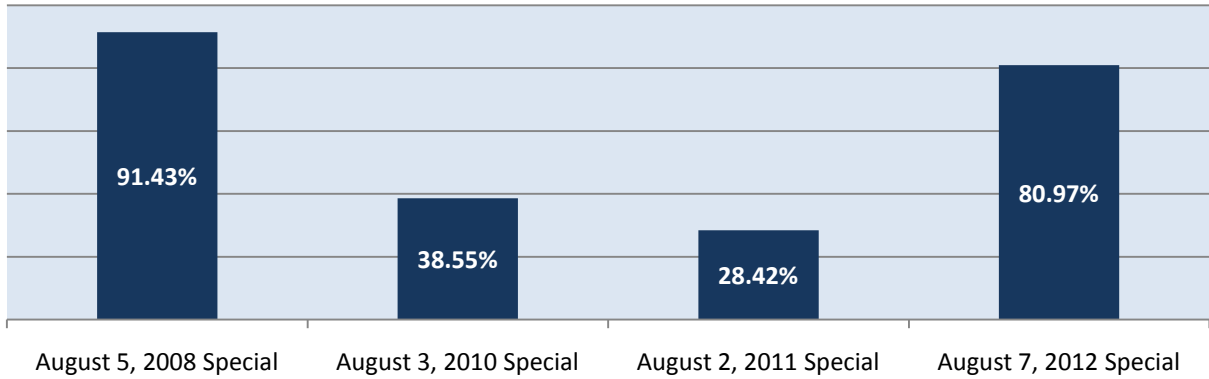

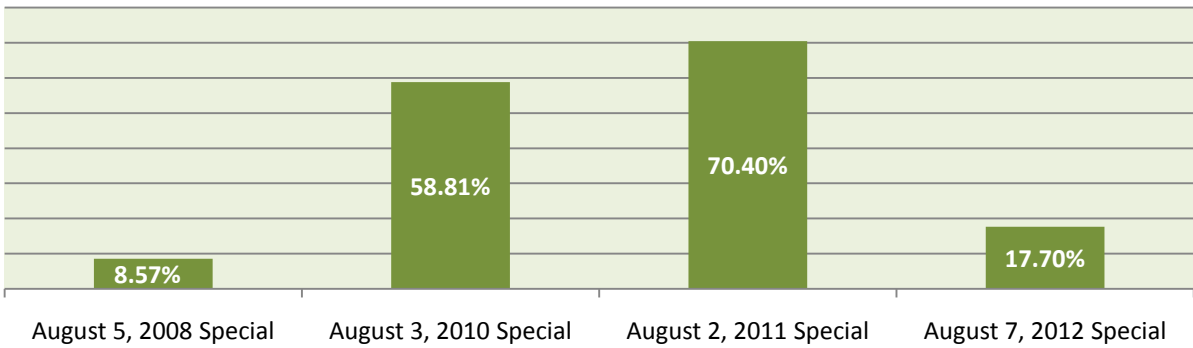

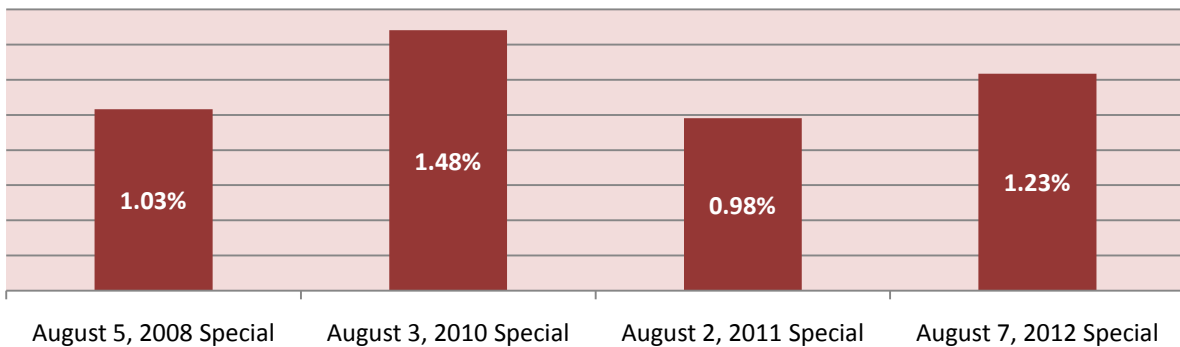
Election Day Voting Trend



Absentee Voting Trend



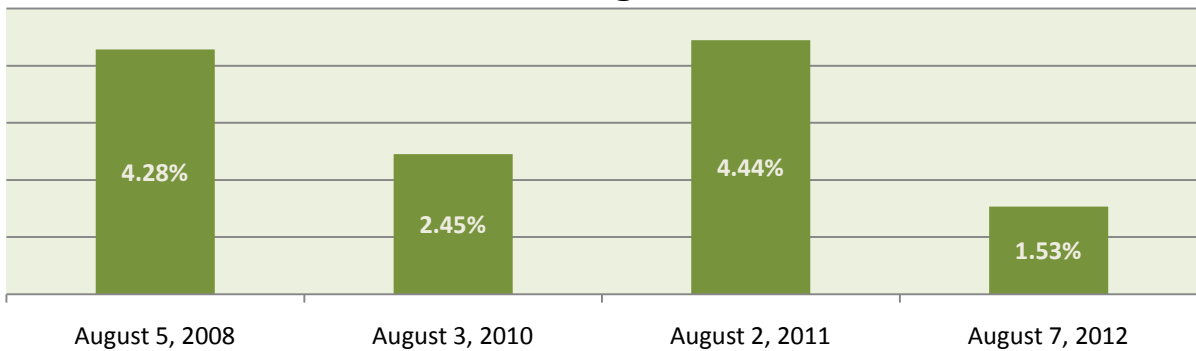
Provisional Voting Trend



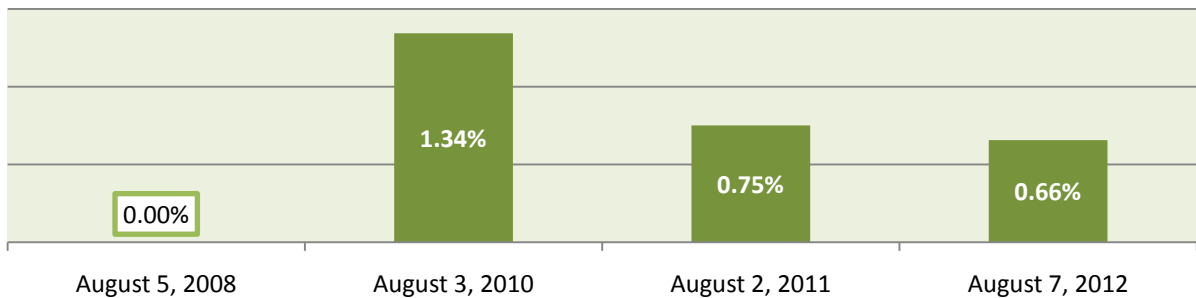

Challenge Rate



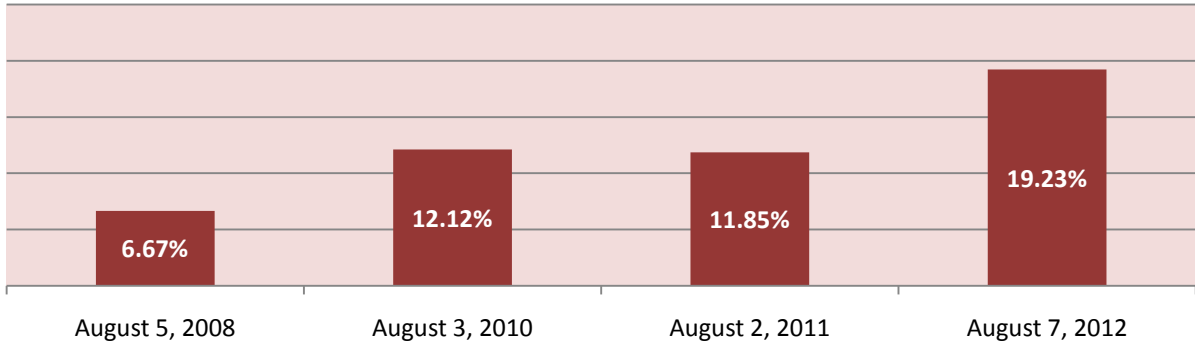
Challenge Rate (Excluding Late)



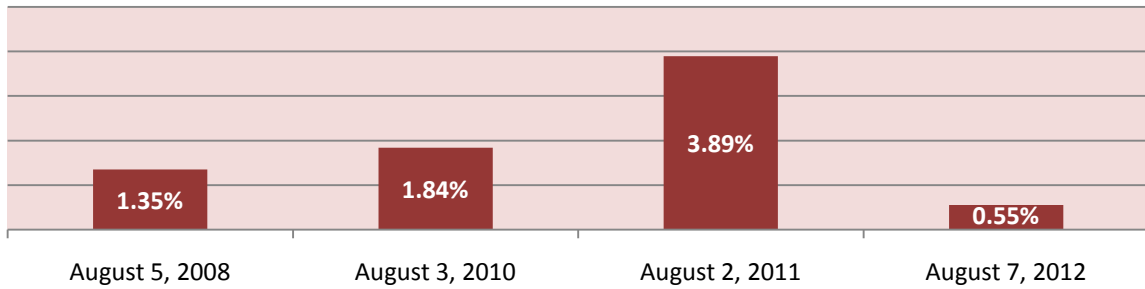
