This request is for petitions received by your office from June 30th 2011 to August 30th 2011 and includes petitions for the repeal of Senate Bill 5 and the Health Care Freedom Amendment. Requested petition signer information should be separated by individual initiative, referendum, candidate or any other type of petition received by your office. We request the data upon the completion of the petition reviews, in which you will report the results to the Secretary of State's office

Information should be in electronic format; Microsoft Excel spreadsheet or CSV file. Electronic files should be sent via email or mailed via CD. Please respond by **July 6** as to whether or not your board of elections will be able to complete this request in electronic format. 2. Any spreadsheet, tally sheet or other record used by the Board to record the validity or invalidity of signatures on the Petition, either signature by signature or by category, and/or to record any part-petitions determined to be invalid.
3. A copy of each part-petition determined to be invalid.
4. All communications from or to the Secretary of State's Office relative to the Petition, excluding Secretary of State Directives, Advisories and Memos sent to all Boards of Elections.
5. All communications from or to persons other than the Secretary of State's Office relative to the Petition.
6. Any public records requests received from other persons relative to the Petition.

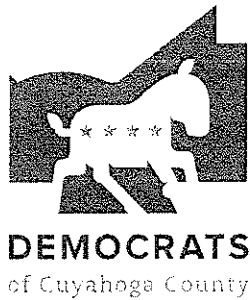
