

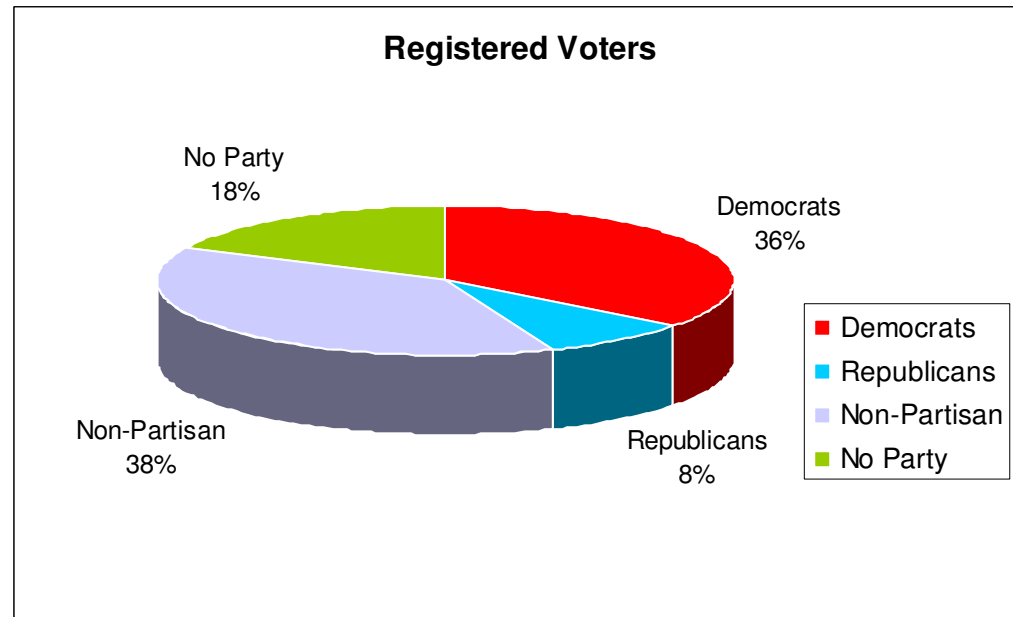

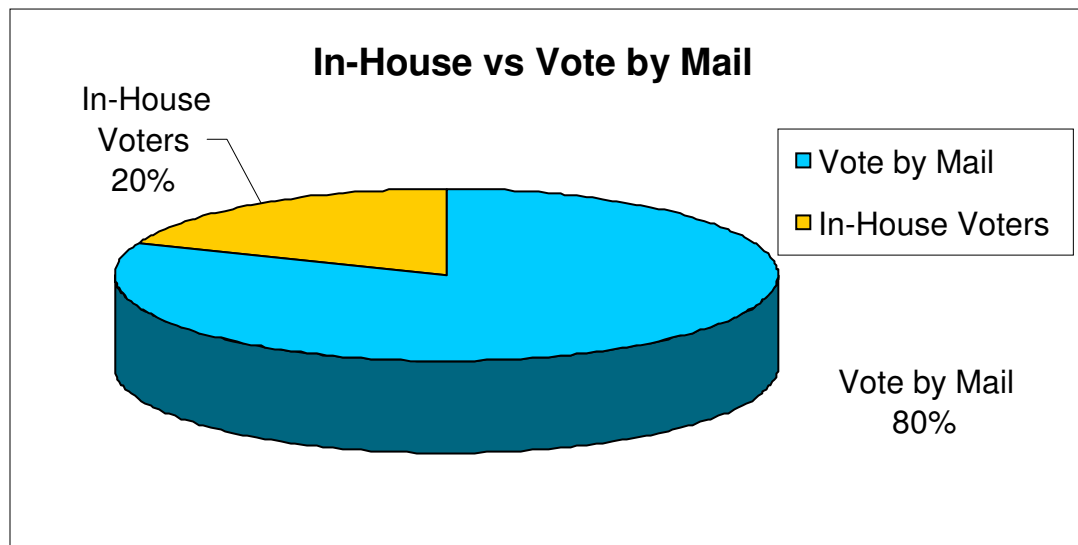

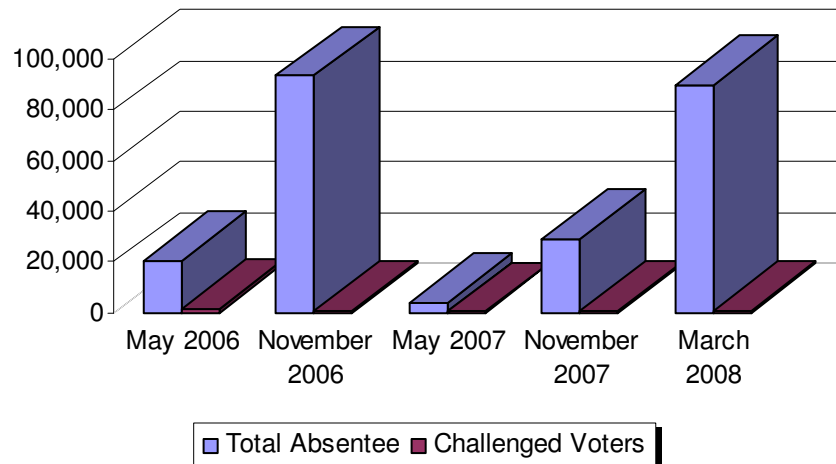

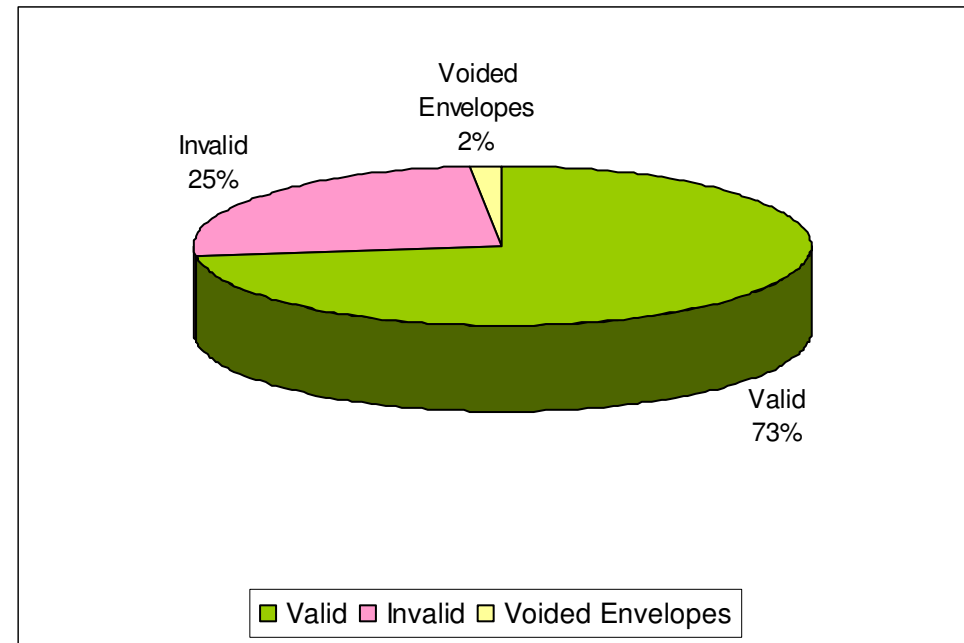

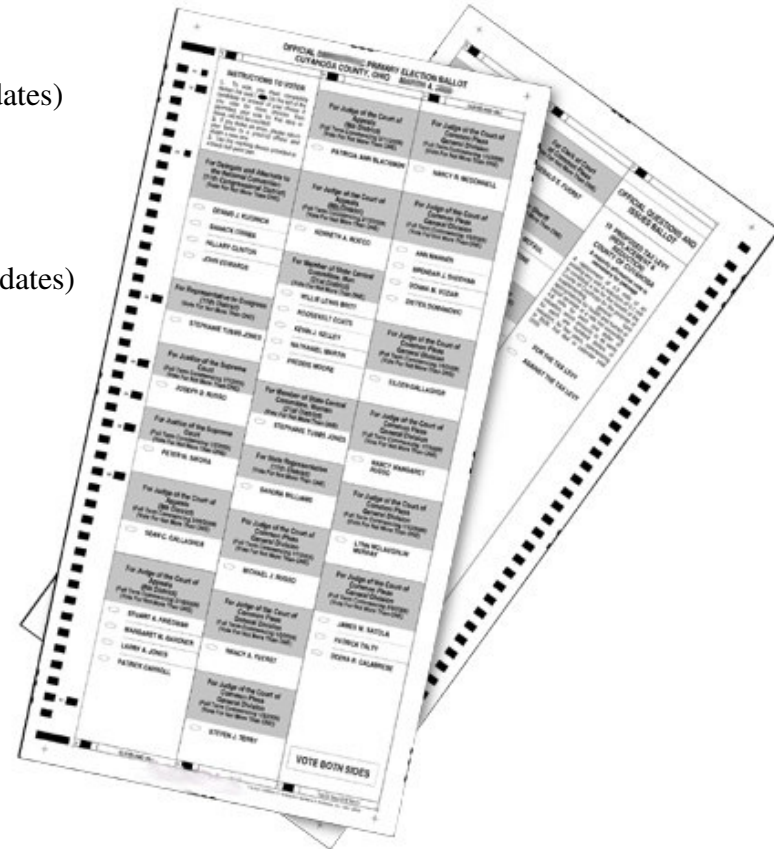

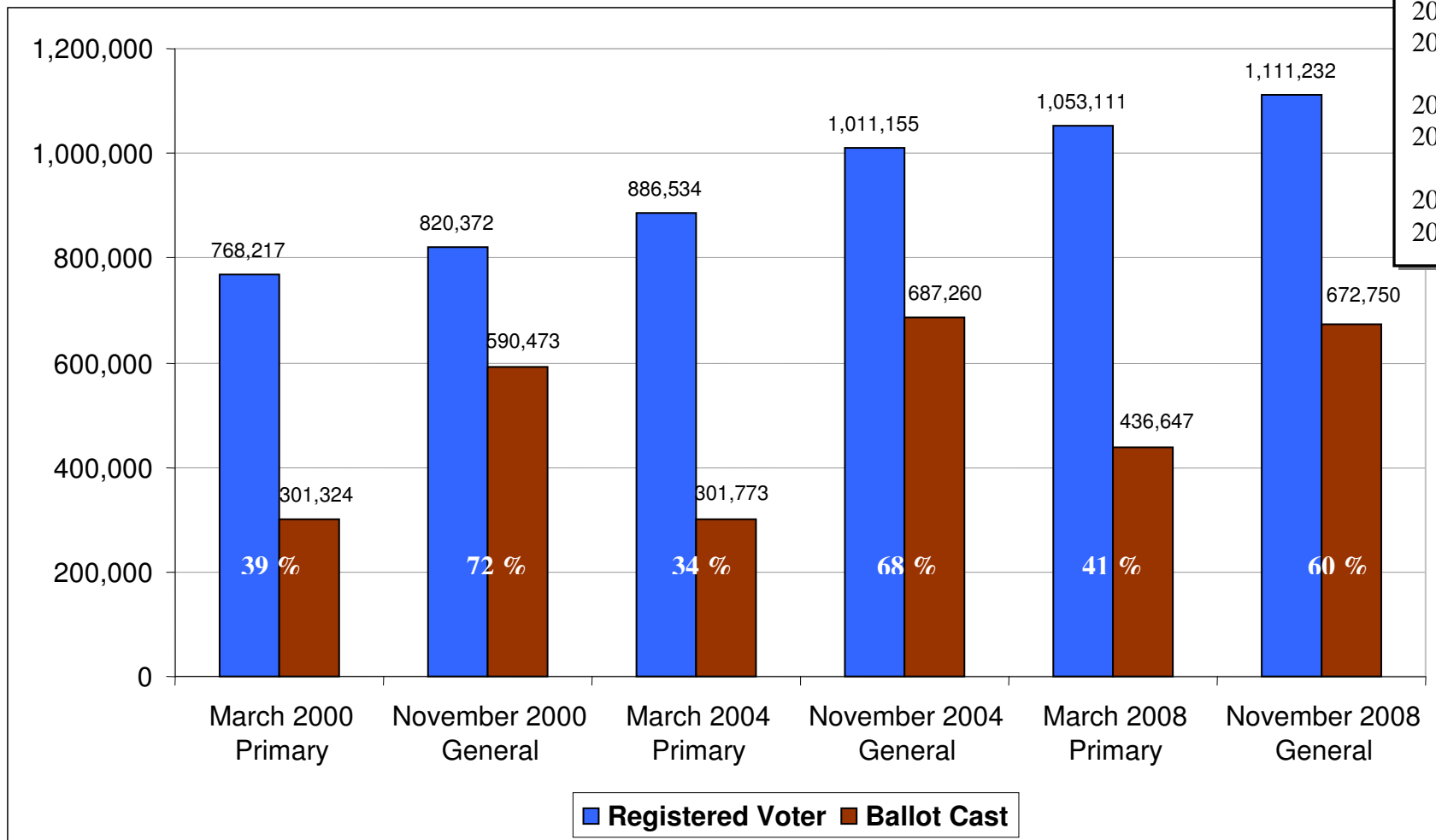

Historic Perspective: Registered Voters vs. Ballots Cast Presidential Election Years, 2000 to 2008

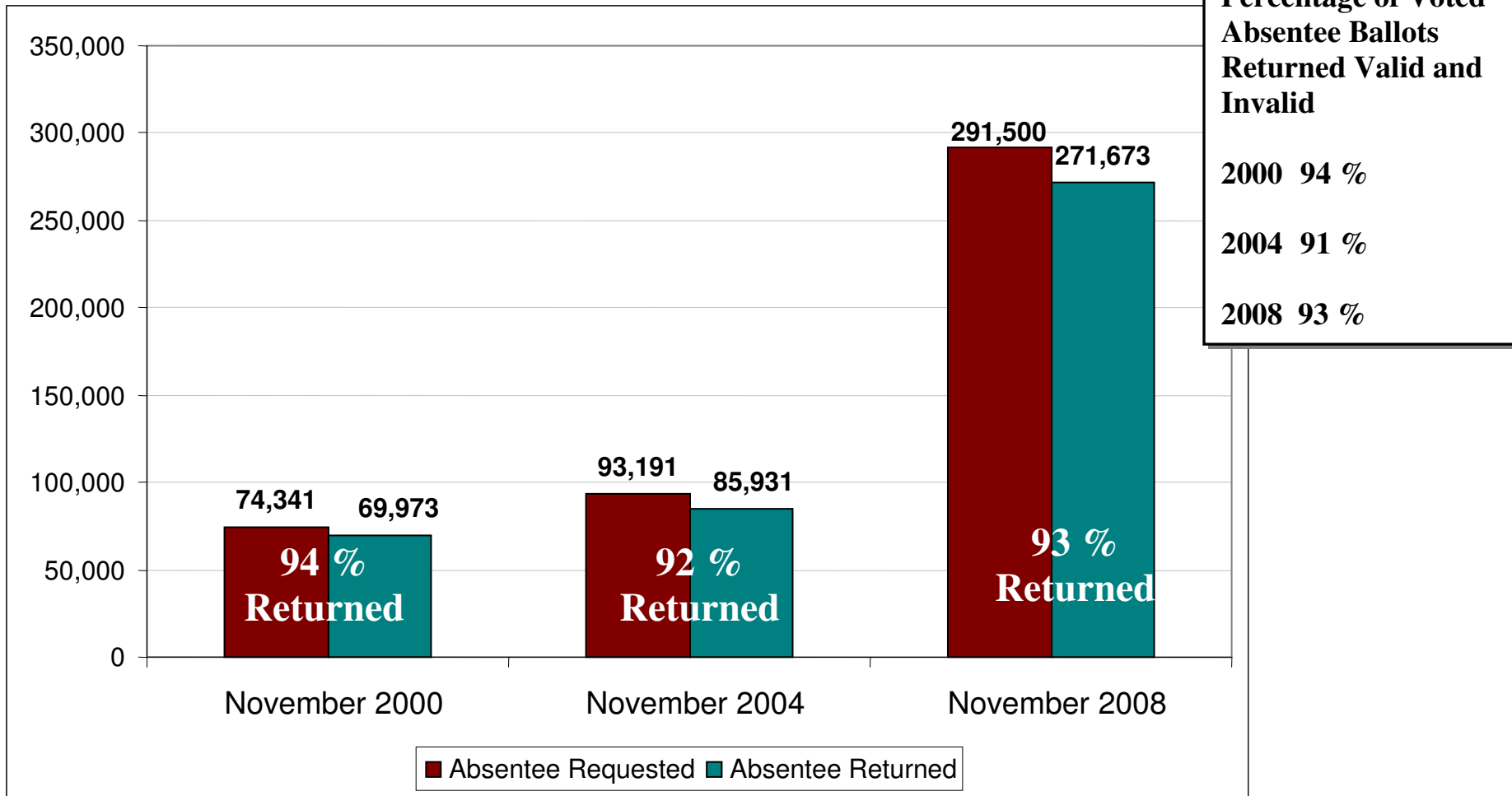

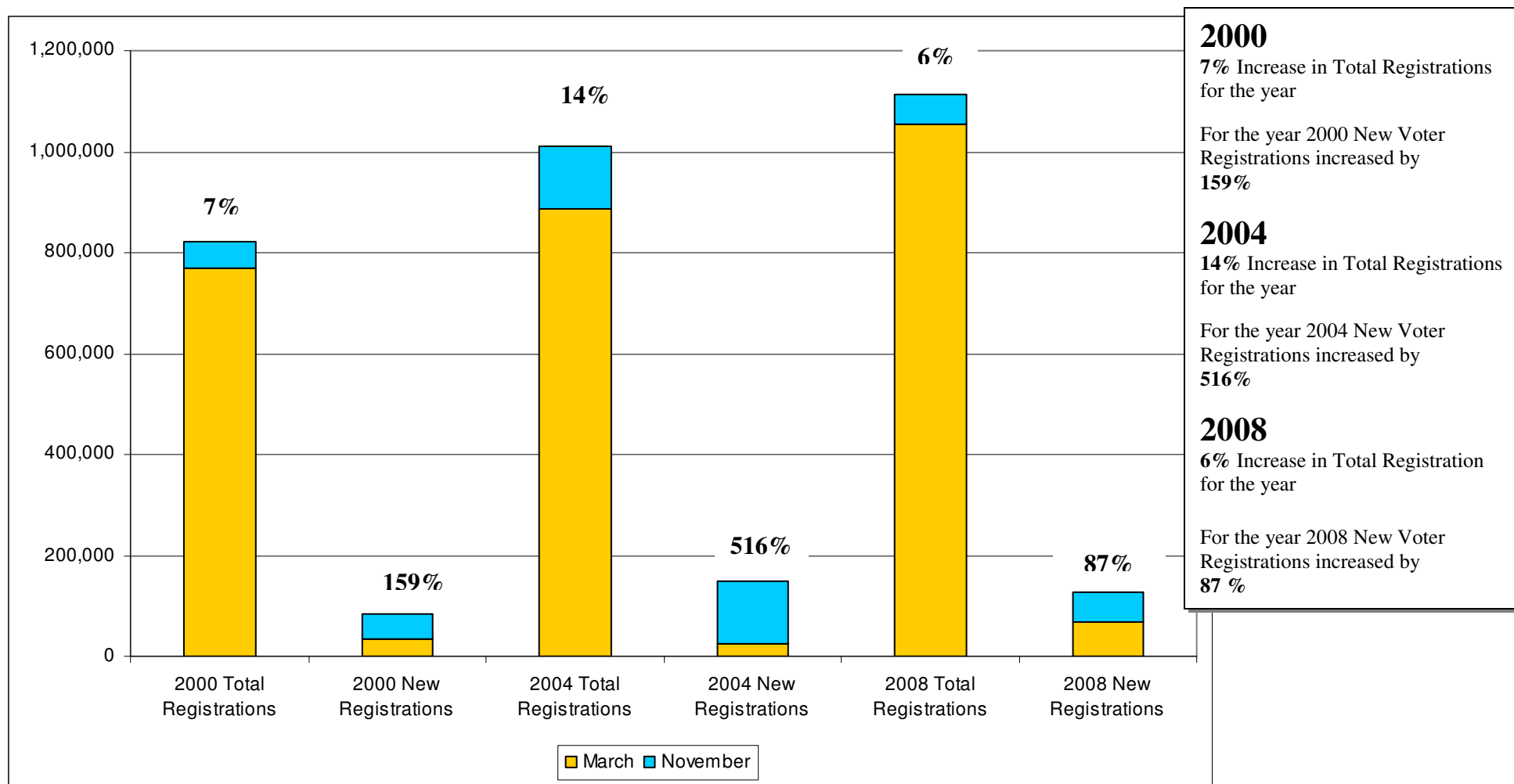




Historic Perspective: Absentee Ballots Requested vs. Ballots Returned Presidential Election Years, 2000 to 2008

Post Election Audit Results

Phase I

- 68 Precincts were chosen at random for the audit
- 5 % of the total ballots cast in the presidential race
- 33,839 ballots audited
- 48 vote difference from the official count to the audit hand count
- **99.86 % Percent Accuracy Rate in Phase One of Audit**

Phase II

Phase Two of the audit was conducted as required by the Secretary of State after the Phase One of the audit exceeded a two vote margin.

- 38 Precincts were chosen at random for the audit
- 3 % of the total ballots cast in the presidential race
- 20,401 ballots audited
- 13 vote difference from the official count to the audit hand count
- **99.94 % Percent Accuracy Rate in Phase Two of Audit**
