

**PROCLAMATION
NOTICE OF PRIMARY ELECTION AND SPECIAL ELECTION**

R.C. 3501.03

The Board of Elections of Cuyahoga County, Ohio issues this Proclamation and Notice of Election.

A PRIMARY AND SPECIAL ELECTION WILL BE HELD ON

TUESDAY, the 7th day of May, 2019

at the usual places of holding elections in each and every precinct in the Village of Bratenahl, City of Broadview Heights, City of Brooklyn, Village of Chagrin Falls, City of Euclid, Village of Mayfield Village, Village of Oakwood, City of Parma, City of Parma Heights, City of Seven Hills, City of Strongsville, or at such places as the Board may designate, to nominate candidates:

and determining the following questions and issues:

SCHOOL DISTRICT ISSUES

Brooklyn City School District

Proposed Tax Levy (Additional) - 6.9 mills for the purpose of avoiding an operating deficit, for ten years, commencing in 2019.

Euclid Library District

Proposed Tax Levy (Renewal) -5.6 mills for the purpose of current expenses, for five years, commencing in 2019.

Parma City School District

Proposed Tax Levy (Renewal) - 4.2 mills for the purpose of providing for the emergency requirements of the District, for ten years, commencing in 2020.

Strongsville City School District

Proposed Tax Levy (Additional) - 5.9 mills for the purpose of providing current expenses, for five years, commencing in 2019.

MUNICIPAL ISSUES

Village of Bratenahl

Proposed Municipal Income Tax (Increase) - providing for a 0.5% levy increase on income, to a rate of 2% levy on income, with 1.5% of such tax for the purpose of general municipal functions of the Village, and 0.5% of such tax for the purpose of operating expenses of the Police Department, Fire and EMS Service Costs and Village Vehicle Replacement Funds, effective June 1, 2019.

City of Broadview Heights

Proposed Zoning Amendment – Shall the Zoning Map of the City of Broadview Heights be amended to change the zoning classification of PP#’s 584-08-004, 584-08-005, 584-08-006 and 584-08-007, located on the North side of Route 82 between Seneca Boulevard and Oakwood Trail, from their current A-1 (Single Family Dwelling) to Special Planning District Zone B?

Village of Chagrin Falls

Proposed Tax Levy (Renewal) - 5.5 mills for the purpose of current expenses, for five years, commencing in 2019.

Village of Mayfield Village

Proposed Zoning Amendment – Shall the Zoning Map of the Village of Mayfield be amended to change the zoning classification of PP#’s 831-10-021, 831-10-007, 831-10-005, 831-10-004, 831-10-006, and 831-10-003, located on Highland Road, from their current U-1 Single Family Residential District and/or Production-Distribution District to the Planned Residential Development District?

Village of Oakwood

Proposed Charter Amendment - Shall Article X of the Charter of the Village of Oakwood be amended by adding new Section 10.13 authorizing the Village Council to permit the construction and operation of video and audio recording, production and editing facilities, helicopter landing and take-off pads accessory to such uses, and passive parks and nature preserves in the area contained within the following boundaries which area is presently zoned R1F Residential: Solon Road on the North, Richmond Road on the East, Hawthorne Parkway on the South and the Oakwood Village border with the City of Bedford Heights on the West, subject to such standards and requirements as are to be established by ordinance of Council?

City of Parma

Proposed Resolution - Shall Section 618.09 (c) of the Codified Ordinances of the City of Parma, which prohibits, within the City, the owning, harboring, or keeping of a pit bull dog, defined by Section 618.01 (z) to include the American Pit Bull Terrier, as recognized by the United Kennel Club, and the American Staffordshire Terrier, the Staffordshire Bull Terrier and the Bull Terrier, as recognized by the American Kennel Club, and any mixed breed of dog which contains as an element of its breeding any of the breeds described, be repealed?

City of Seven Hills

Proposed Tax Levy (Renewal) - 0.5 mill for the purpose of acquiring motorized vehicles and equipment, including a street sweeper, a tractor with front-end loader and a backhoe, a mower, dump trucks, pick-up trucks, and snow plow assemblies, salt spreaders and other related equipment therefor, for use in carrying out functions of the Department of Public Service, for five years, commencing in 2019.

City of Strongsville

Proposed Tax Levy (Renewal) - 1.5 mills for the purpose of current expenses, for five years, commencing in 2019.
