FINAL RESULTS

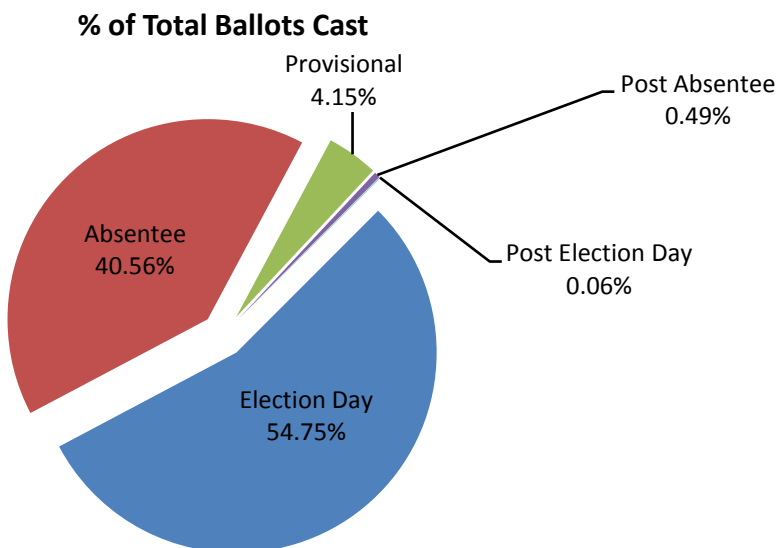
Amended Official Election Results for the November 6, 2012 General Election are attached to the Election Summary Report. Amended results include updates based on the automatic recounts, post-election audit, and the addition of twenty (20) post-absentee and two (2) provisional ballots determined to be valid after the original certification on November 27, 2012.

NOTE: There are seven (7) contests within districts overlapping thirteen (13) surrounding counties. Cuyahoga County is the most populous county in six (6) of those contests. The combined totals of all counties in those six (6) contests are reflected in the "Most Populous Results".

SUMMARY OF OFFICIAL CANVASS

There were a total of 650,414 ballots tabulated for the November 6, 2012 General Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

ABSENTEE / VOTE BY MAIL

The Cuyahoga County Board of Elections received a total of 291,502 valid Absentee/Vote by Mail applications. Of those requests, 269,761 ballots were returned (92.5%). The Ballot Department tabulated 266,984 Absentee / Vote by Mail Ballots (91.6%) of the applications processed. There were 2,777 ballots challenged in this election resulting in a challenge rate of 1.03%*. Details of the challenges are below.

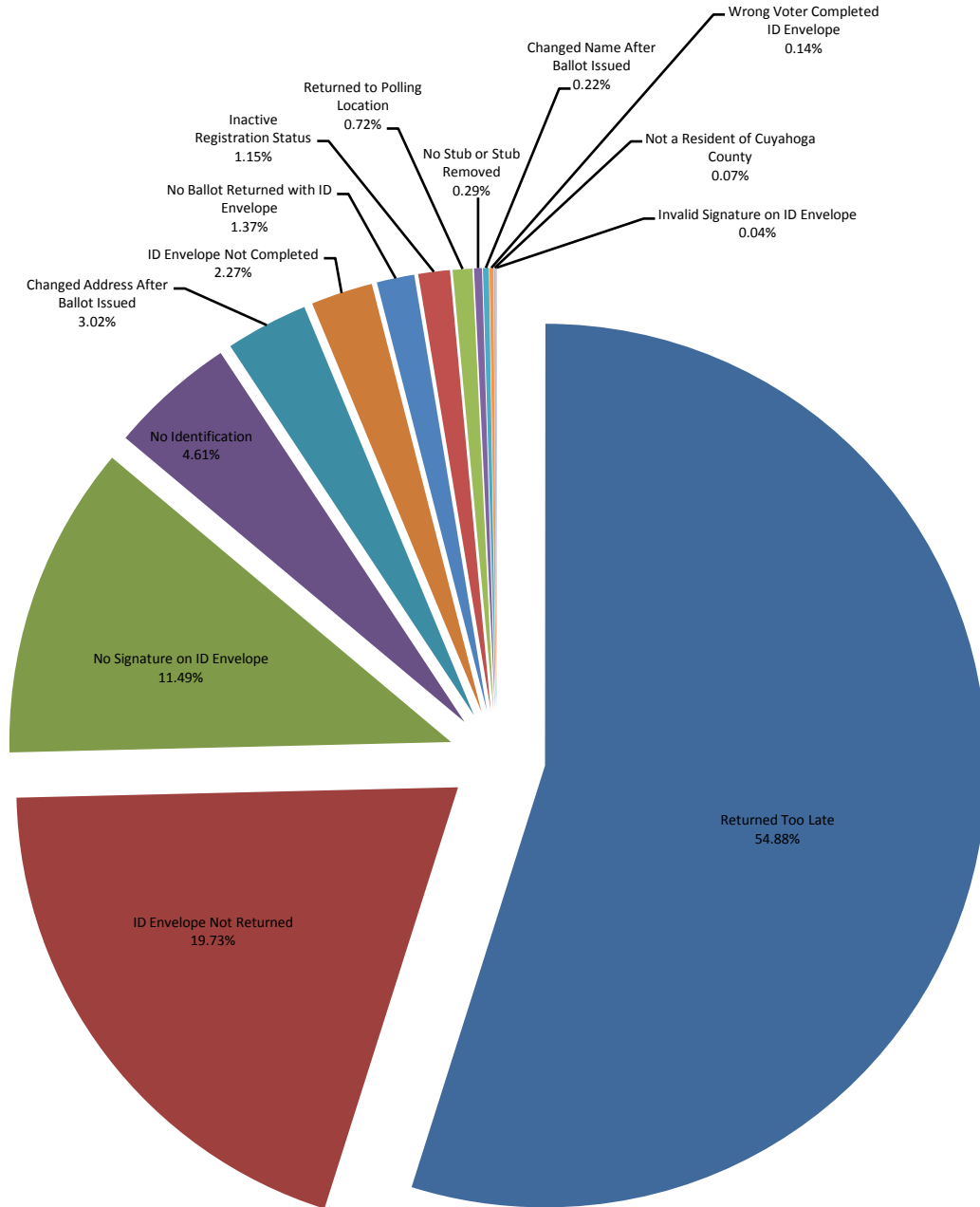
*The Absentee Ballot Challenge Rate is 0.47% when the Absentee Ballots postmarked after the deadline are excluded.

PROVISIONAL VOTING SUMMARY

A total of 31,848 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 26,968 (84.68%) were valid and tabulated by the Ballot Department. There were 4,880 invalid Provisional Ballots resulting in a 15.32%* rejection rate for this election. Details of the rejections are below.

* The Provisional Ballot Rejection Rate is 6.23% when Provisional Voters who have already cast an Absentee Ballot and those who are not currently registered to vote are excluded.

BALLOT REMAKES

During the election, 12,039 ballot pages were processed in accordance with the CCBOE Remake Policy (approved by the Board on November 2, 2012). Of those, 4,915 ballot pages were processed during the Unofficial Canvass; the remaining 7,124 were processed during the Official Canvass. The following is a breakdown by category:

OVER VOTES

There were a total of 10,535 over votes recorded, resulting in a 0.05% over vote rate for the election. The exact number of over voted ballots is unknown as the Unity system reports over votes on a per-contest basis, thus a ballot containing multiple over votes is recorded multiple times. A detailed listing of over votes cast by contest is attached.

POLL BOOK JUSTIFICATION AND BALLOT RECONCILIATION

All 1,063 precincts were involved in this election. The number of signatures in the Poll Books matches the number of Ballots Cast in 715 (67%) precincts. Below is a breakdown of the range of discrepancies between the number of signatures in the poll books and the number of ballots cast on Election Day.

A review of the ballots cast on Election Day was completed for all of the precincts with a discrepancy.

A review of the Ballot Reconciliation has 620 (57%) precincts reconciling. Below is a breakdown of the range of discrepancies in the remaining precincts:

A review of the data by polling location indicates that 177 of the 461 precincts reconcile at the polling location. This increases the total number of reconciled precincts to 797 (74%).

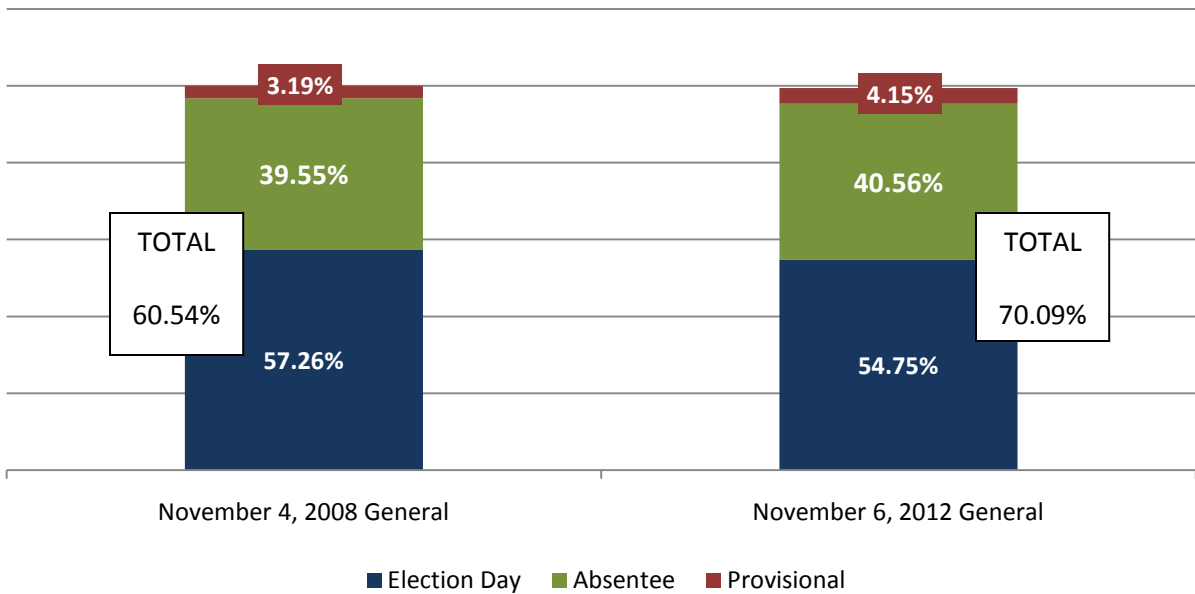

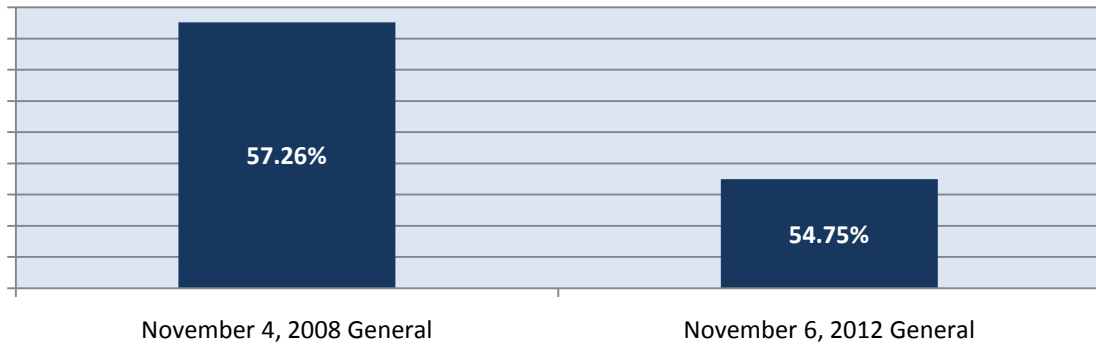

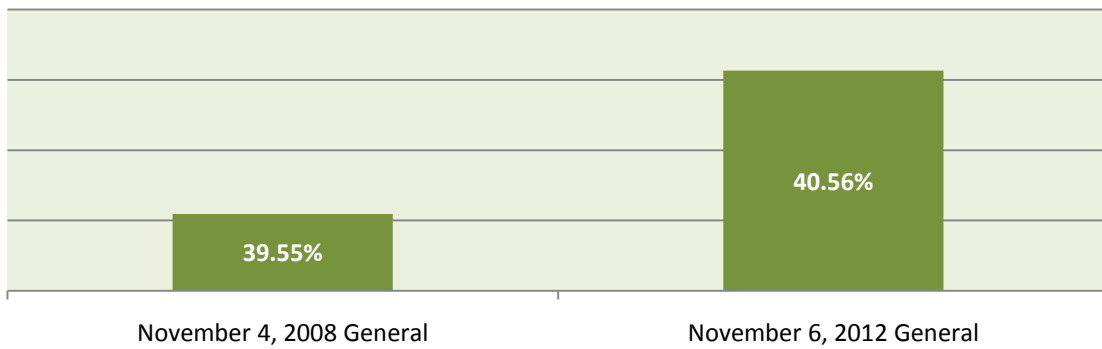

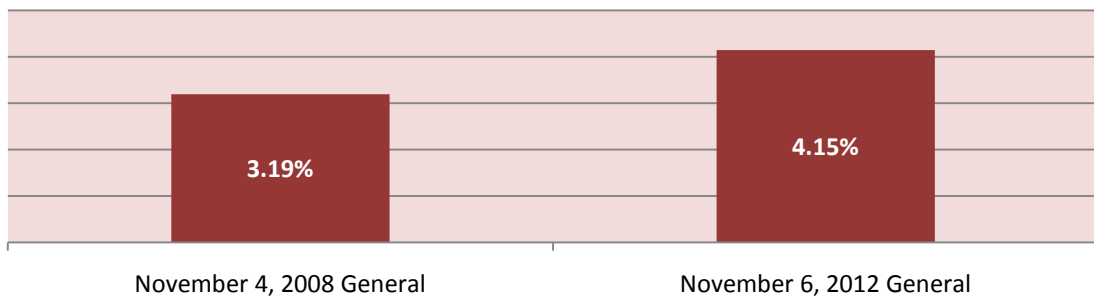
Election Day Voting Trend



Absentee Voting Trend



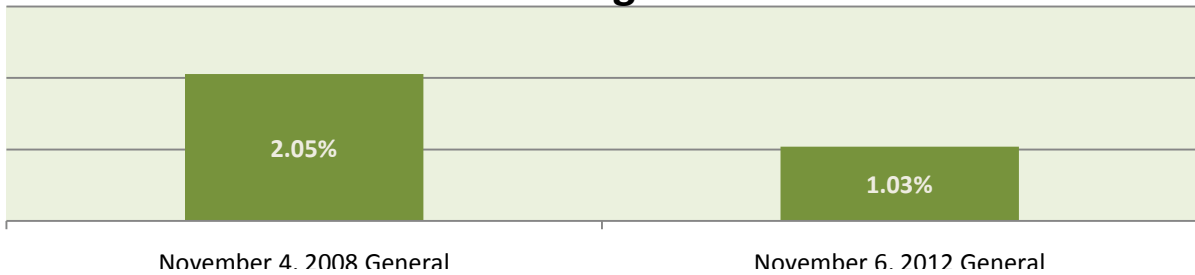
Provisional Voting Trend



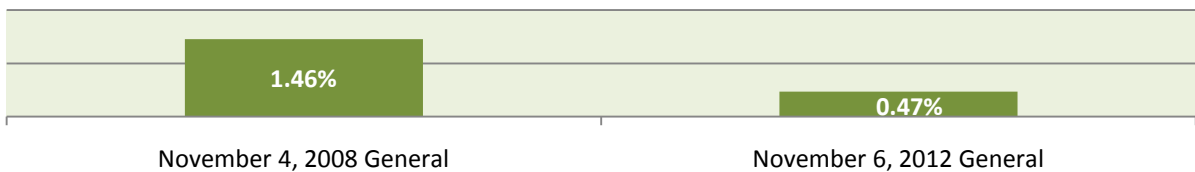

Challenge Rate



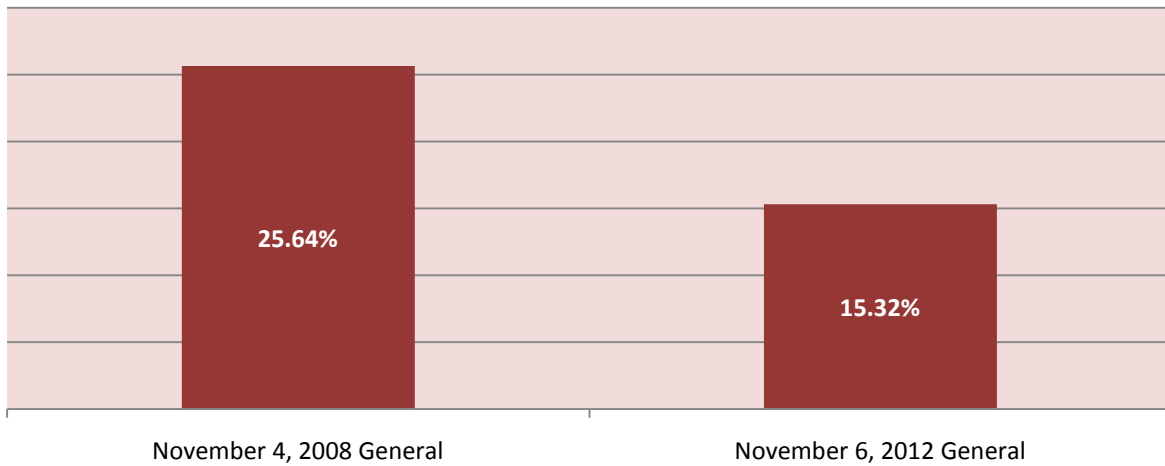
Challenge Rate (Excluding Late)



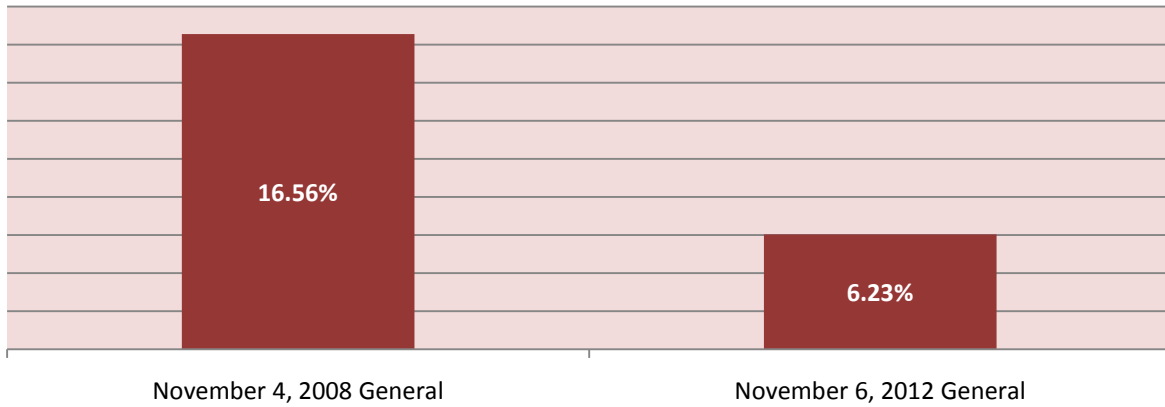

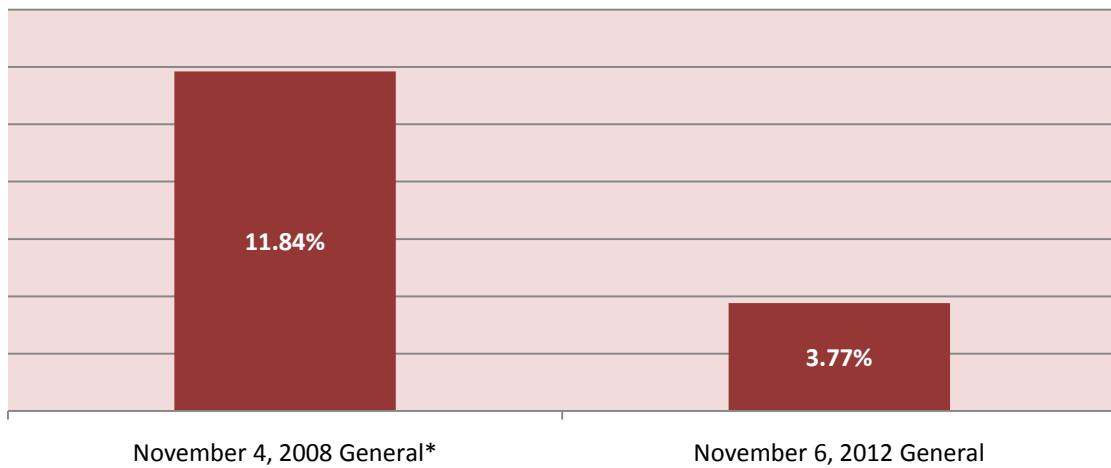
Rejection Rate
