FINAL RESULTS

Official Election Results for the November 4, 2014 General Election are attached to the Election Summary Report.

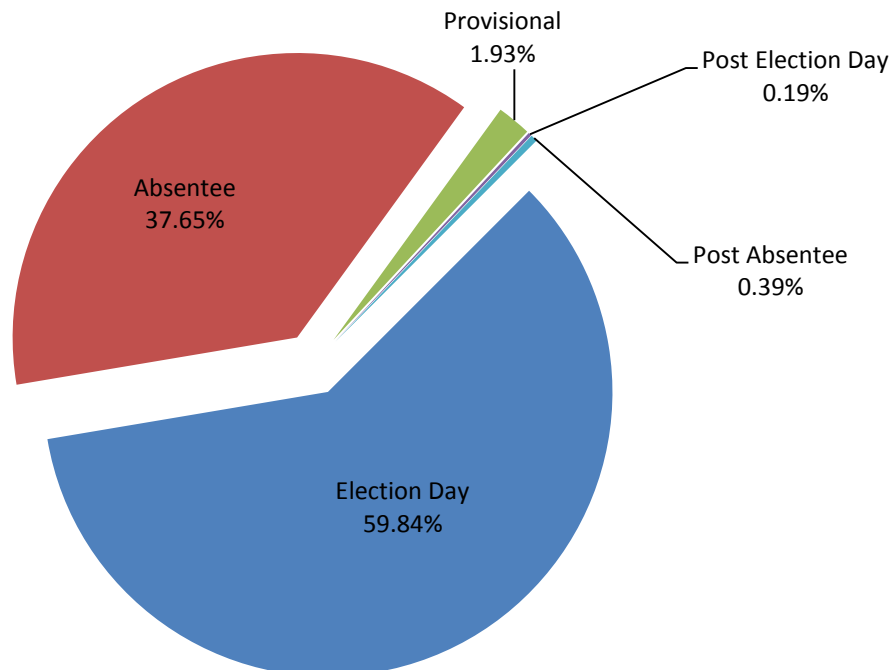
NOTE: There are six (6) contests within districts overlapping sixteen (16) surrounding counties. Cuyahoga County is the most populous county in five (5) of those contests, overlapping thirteen (13) counties. Eleven of those counties have certified their results to date. The remaining two counties will be certifying today. All certified results will be entered into the required reporting form upon receipt and forwarded to the Secretary of State.

SUMMARY OF OFFICIAL CANVASS

There were a total of 350,534 ballots tabulated for the November 4, 2014 General Election. Below is a breakdown of the ballots counted by category and a percentage of the total vote by category.

ABSENTEE / VOTE BY MAIL

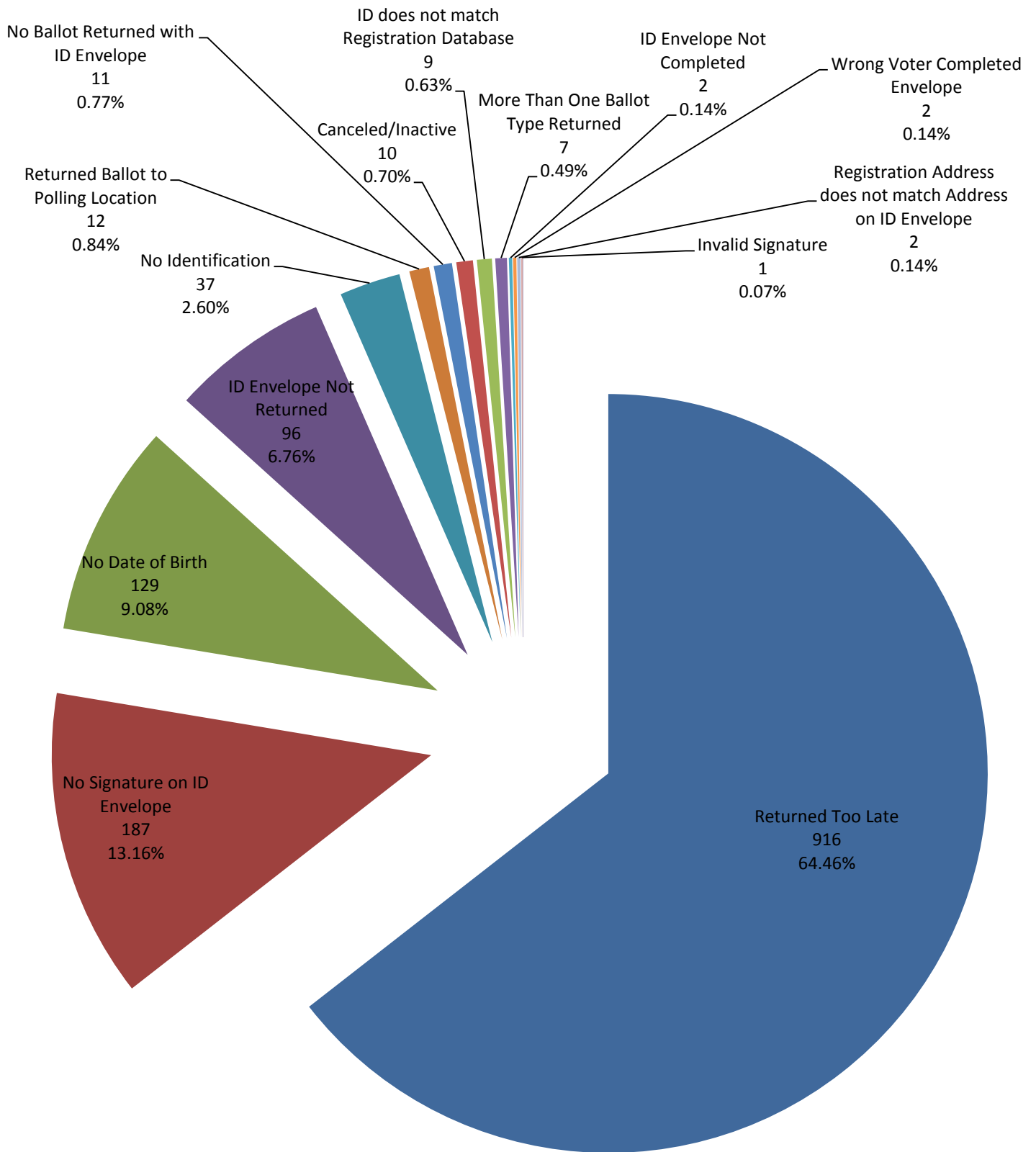
The Cuyahoga County Board of Elections received a total of 153,340 valid Absentee/Vote by Mail applications. Of those requests, 135,146 ballots were returned (88.13%). The Ballot Department tabulated 133,331 Absentee/Vote by Mail Ballots of the applications processed. There were 1,421 ballots challenged in this election resulting in a challenge rate of 1.05%*. Details of the challenges are below.

*The Absentee Ballot Challenge Rate is 0.37% when the Absentee Ballots postmarked after the deadline are excluded.

PROVISIONAL VOTING SUMMARY

A total of 7,536 Provisional Ballots were cast In-House and on Election Day. Of those ballots, 6,780 (89.97%) were valid and tabulated by the Ballot Department. There were 756 invalid Provisional Ballots resulting in a 10.03%* rejection rate for this election. Details of the rejections are below.

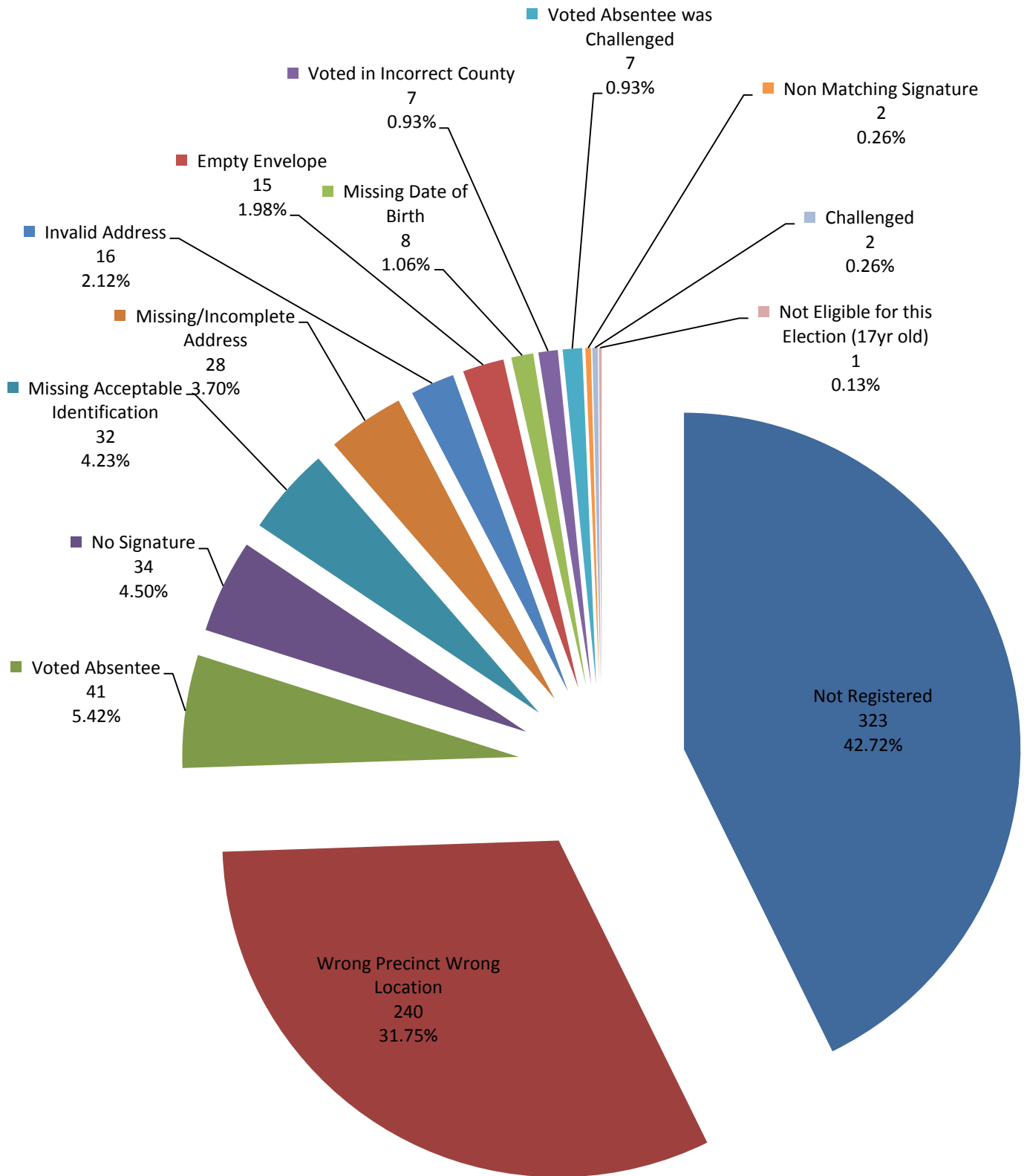
* The Provisional Ballot Rejection Rate is 5.37% when Provisional Voters who have already cast an Absentee Ballot and those who were registered to vote are excluded.

BALLOT REMAKES

During the election, 4,539 ballot pages were processed in accordance with the CCBOE Remake Policy (approved by the Board on May 17, 2013). Of those, 2,062 were processed during the Unofficial Canvass. The remaining 2,477 ballot pages were processed during the Official Canvass. The following is a breakdown by category:

OVER VOTES

There were a total of 6,313 over votes recorded, resulting in a 0.05% over vote rate for the election.

VOTER HISTORY /BALLOT RECONCILIATION

There are 1,047 precincts involved in this election. The Registration Department is still in the process of reviewing each poll book for the voter history process.

Ballot Reconciliation is currently being performed by the Ballot Department.

RECOUNTS

There are no automatic recounts this election.

The requested recount deadline is Monday, December 1st, 2014.

AUDIT

The post-election audit is scheduled to begin Monday, December 8th at 9:30AM if no recounts are required to be conducted. If recounts are requested, those will begin Monday, December 8th and the post-election audit will be postponed until the business day after the completion of any necessary recounts and subsequent certification amendments. The Board and observers will be notified as soon the schedule is confirmed (after the requested recount deadline). Additionally, the schedule will be posted to our website.

The post-election audit will include:

Governor / Lieutenant Governor – Selected by the Secretary of State's Office

Treasurer of State – Randomly selected by the Secretary of State's Office

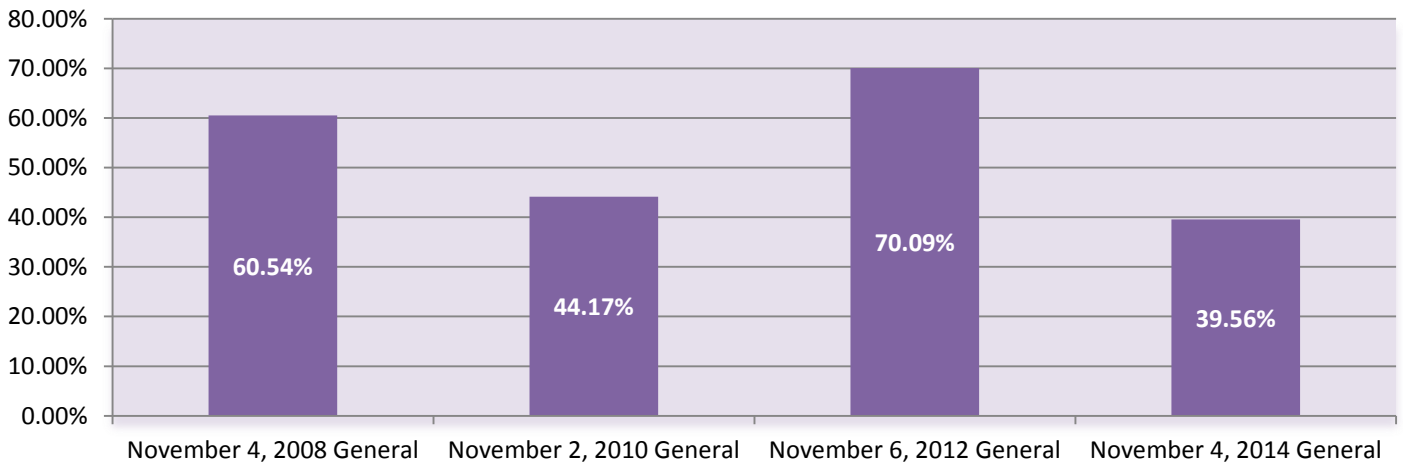
One contest to be randomly selected by the Board during the certification meeting (possible contests are attached)

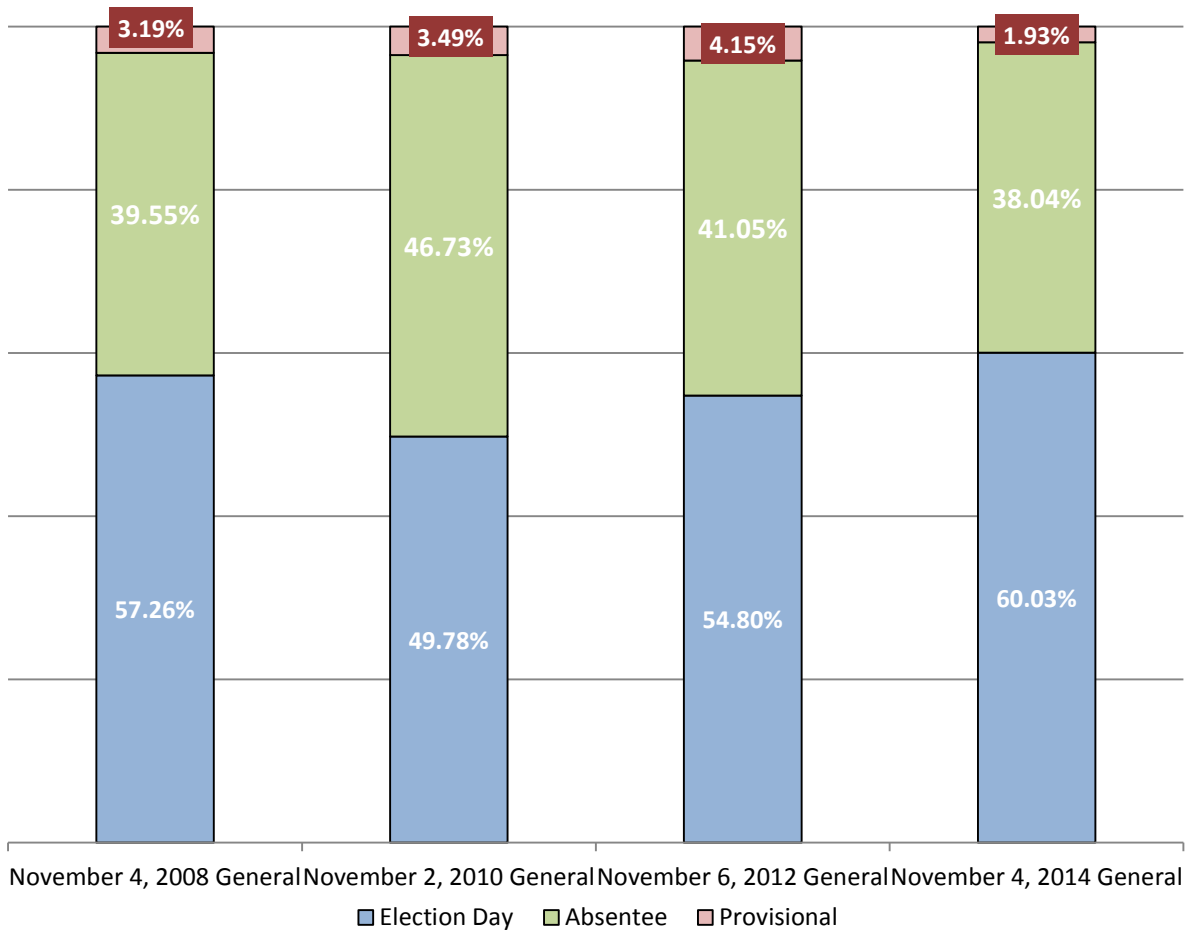
Overall Voter Turnout

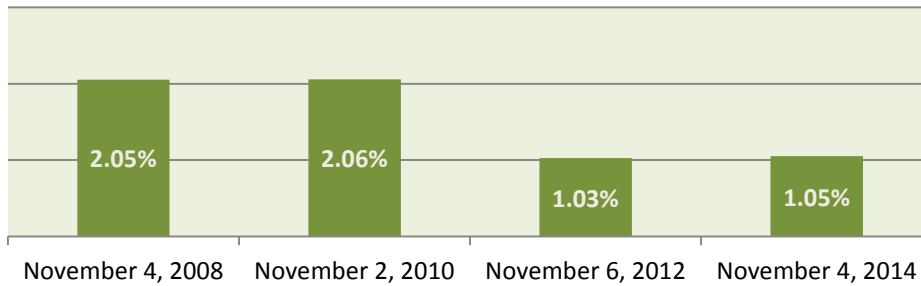
Voter Turnout by Category



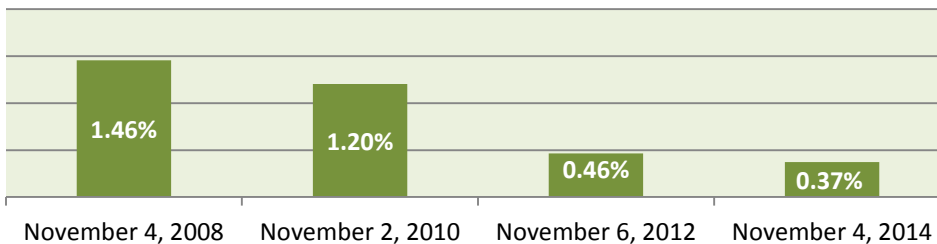

Challenge Rate



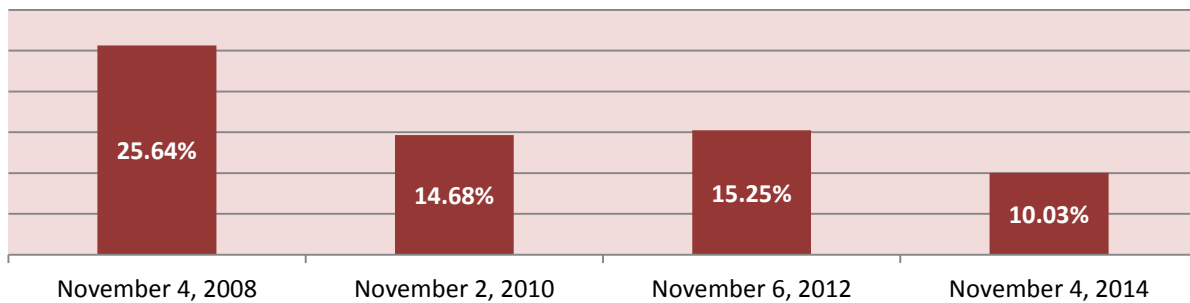
Challenge Rate (Excluding Late)



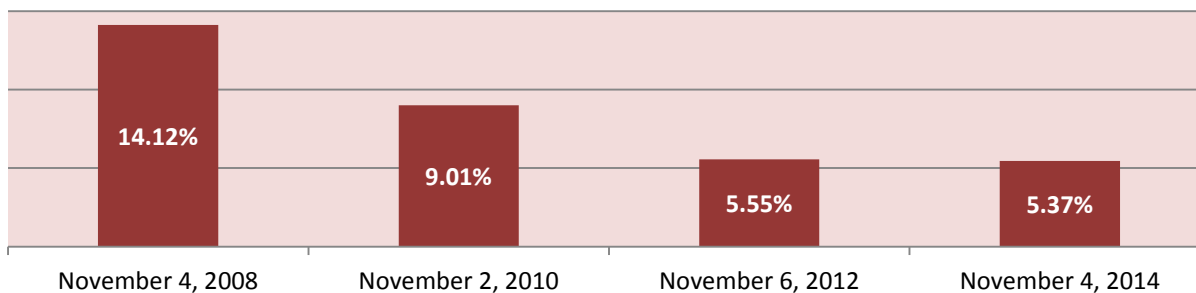
